Employee invention law - in particular the compensation of employee inventors - can pose significant legal and procedural challenges. There is a multitude of different compensation models, ranging from strict adherence to the official guidelines to one-time flat-fee payment models. After a general introduction into the topic, the speakers will discuss various models and will comment on their advantages and disadvantages.

Contrary to patent protection, know-how protection is often not the primary focus of companies, although it can be a useful tool to secure a company's technological edge.

The seminar will cover the legal basics of know-how protection as well as its practical implementation, in particular with regard to R&D cooperations and the like. Practical implications due to the planned EU Know-How Directive will also be presented.
